I understand that there are possible dangers associated with the Program, including, but not limited to, stinging and biting animals, poison ivy, injuries by falling while hiking, high heat and humidity, and weather events. I understand that my participation in the Program may involve sustained strenuous physical activity. I am in good health and am aware of no physical problem or condition that will limit or interfere with my ability to participate in the Program.

I agree that I am participating in the Program at my own risk, and acknowledge that the Friends Group has made no warranty or representation, expressed or implied, regarding the safety of conducting the Program.

I expressly release and hold harmless the Friends Group, the City of Joplin, and its officers, directors, employees, agents, licensees, successors and members of City Council and assigns from and for any and all claims, demands, actions and causes of action whatsoever for (i) libel, defamation, invasion of privacy or right of publicity arising from the Friends Group use or alteration of My Likeness (or any part thereof); or (ii) any loss, damage or injury to person or to property suffered or incurred by me in connection with the Program or any aspect of it, including, but not limited to, any transportation arranged by, paid for or provided by the Friends Group.
